The total estimated cost that must be shown on the Affidavit of Financial Support does not include tuition, international service charges, or books for the summer sessions. If a student wishes to attend classes during the summer sessions, summer tuition for 6 credit hours, **books** (\$200), and **fees** (\$60) are estimated to be an additional \$4,355.00 for undergraduate study and \$5,720.00 for graduate study. Per credit hour cost for summer study is \$682.50 / hr. for undergraduate study and \$910.00 / hr. for graduate study.



## Affidavit of Financial Support

### Please read the following prior to completing this form:

The purpose of the *Affidavit of Financial Support* is to help the University of Mississippi obtain complete and accurate information about the funds available to international applicants who wish to study at the university. Strict government regulations require the University of Mississippi to verify the financial resources of each international applicant prior to issuance of either the Form I-20 or the DS-2019.

- **Undergraduate/Graduate** (not including MBA/Law/Pre-Pharmacy) students are required to provide evidence of funds in the amount of at least **\$41,426.00**;
- **Undergraduate Pre-Pharmacy** students are required to provide evidence of funds in the amount of at least **\$47,306.00**;
- **Graduate MBA** students are required to provide evidence of funds in the amount of at least **\$70,054.00**;
- **Law Students** are required to provide evidence of funds in the amount of at least **\$53,226.00**;

Students must have a plan to support themselves during their entire length of study. All fees are based on estimated costs and are subject to change at any time. On-campus employment is not guaranteed and should not be seen as a significant means of support while at the university.

Arrangements should be made to have funds available at the time of registration for each semester. Payment of tuition and fees for a student's first semester is due on the day of class registration. A 1½ percent monthly service fee is added to the balance due after the payment deadline.
